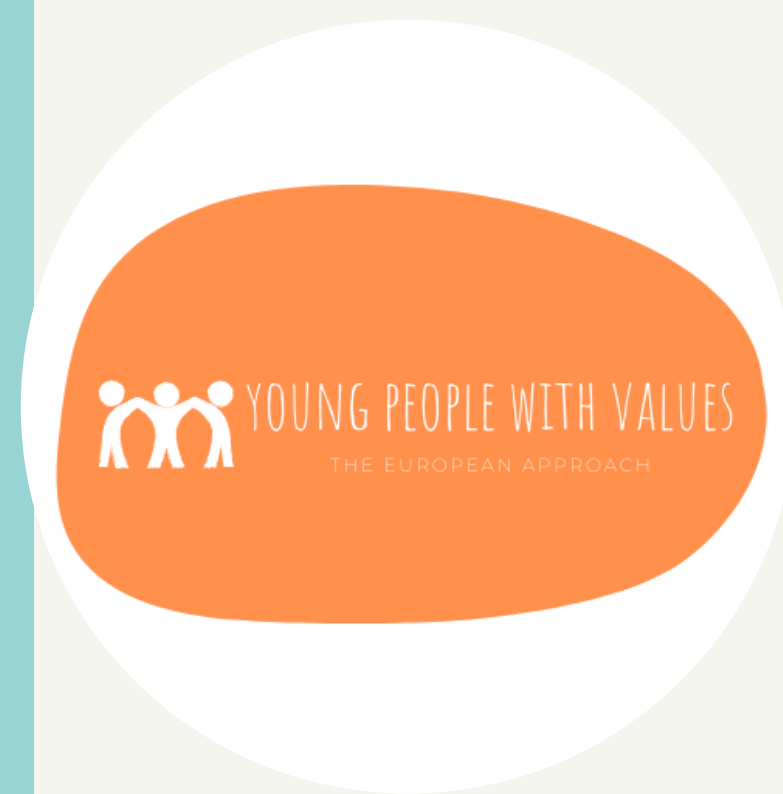

## Analysis of Jove Valor, the good practice

Before starting with the development of the results for the 'Young People with Value' model, there was an analysis done on what the Jove Valor actually is built upon. Also, the YoPeVa's partners and their stakeholders were asked which relevant successful elements deployed in their region could be added to the original good practice.

So in short, the first step was to analyse the existing Jove Valor project and similar good practices, which resulted in three main recommendations:

Funding has been a challenge for similar initiatives, so we need to address **sustainability and funding sources** already in an early stage.

There needs to be a lot of **room for adaptation to local and regional realities**.

Most importantly, we need to do it **together with the stakeholders**.

**Engagement and inclusion are key!**

YoPeVa Innovation Book, establishes the methodological approach of 'Young People with Values' Program model, to be applied in the consortium by all partners and beyond. This will be done through a knowledge transfer and interchange, from the lead partner to the whole consortium and back, doing a permanent analysis addressed to define the way to scale-up the initial good policy methodology at European level.
